NOTICE OF PUBLIC HEARING ON TAX INCREASE

A tax rate of \$0.479400 per \$100 valuation has been proposed by the governing body of **CITY OF CELESTE.**

PROPOSED TAX RATE \$0.479400 per \$100

NO-NEW-REVENUE TAX RATE \$0.461405 per \$100

VOTER-APPROVAL TAX RATE \$0.479478 per \$100

The no-new-revenue tax rate is the tax rate for the 2022 tax year that will raise the same amount of property tax revenue for CITY OF CELESTE from the same properties in both the 2021 tax year and the 2022 tax year.

The voter-approval rate is the highest tax rate that CITY OF CELESTE may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that CITY OF CELESTE is proposing to increase property taxes for the 2022 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON September 6, 2022 AT 6:30 PM AT Celeste City Hall, 201 North US Highway 69, Celeste, Texas 75423.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, CITY OF CELESTE is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the City Council of CITY OF CELESTE at their offices or by attending the public hearing mentioned above.

The 86th Texas Legislature modified the manner in which the voterapproval tax rate is calculated to limit the rate of growth of property taxes in the state.
