5. City Council Comments: Pursuant to TEX. GOV'T CODE 551.0415(b), the Mayor and each City Council member may announce city events/community interests and request that items be placed on future City Council agendas.

Comments related to public hearings will be heard during those hearings. Each speaker is limited to three (3) minutes, or six (6) minutes if a translator is needed, as stated by law. To speak, sign up before the meeting starts. Speakers should come to the front of the Council and state their name and street address before starting. All comments must be civil to ensure constructive discussion. The public cannot speak from the gallery; only those at the front of the Council may do so. Per the Texas Open Meetings Act, the Council is not permitted to act on or discuss any item not listed on the agenda. The Council may: (1) make a statement of fact regarding the item; (2) make a recitation of existing policy; or (3) propose the item be placed on a future agenda, in accordance with Council procedures.
